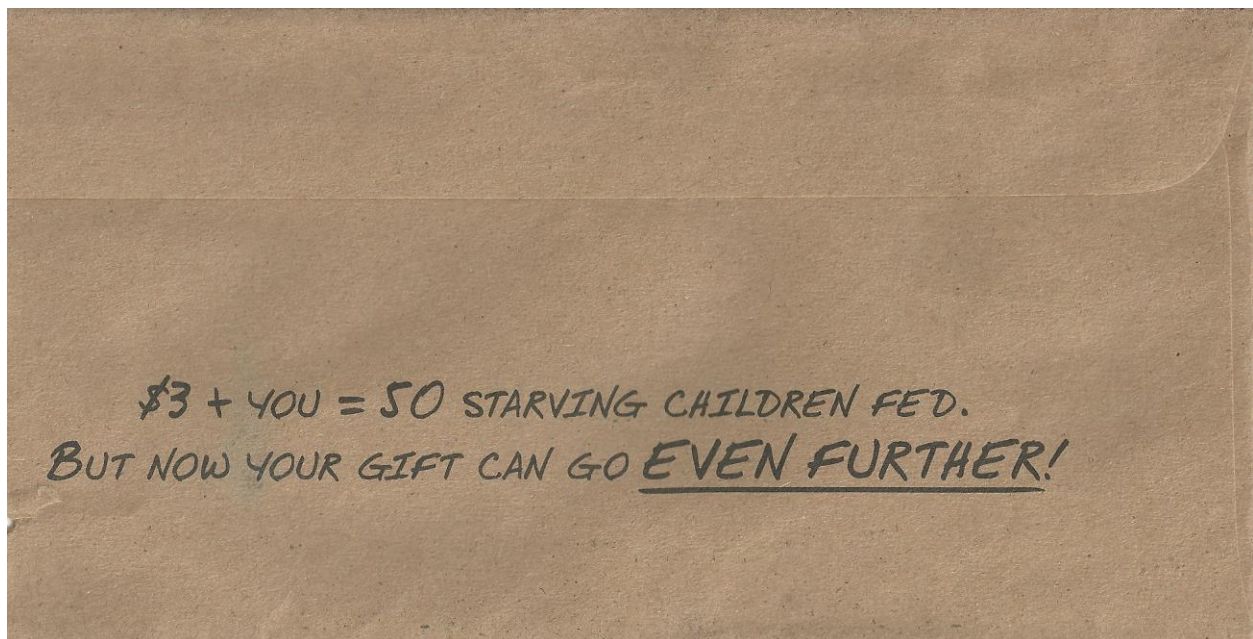
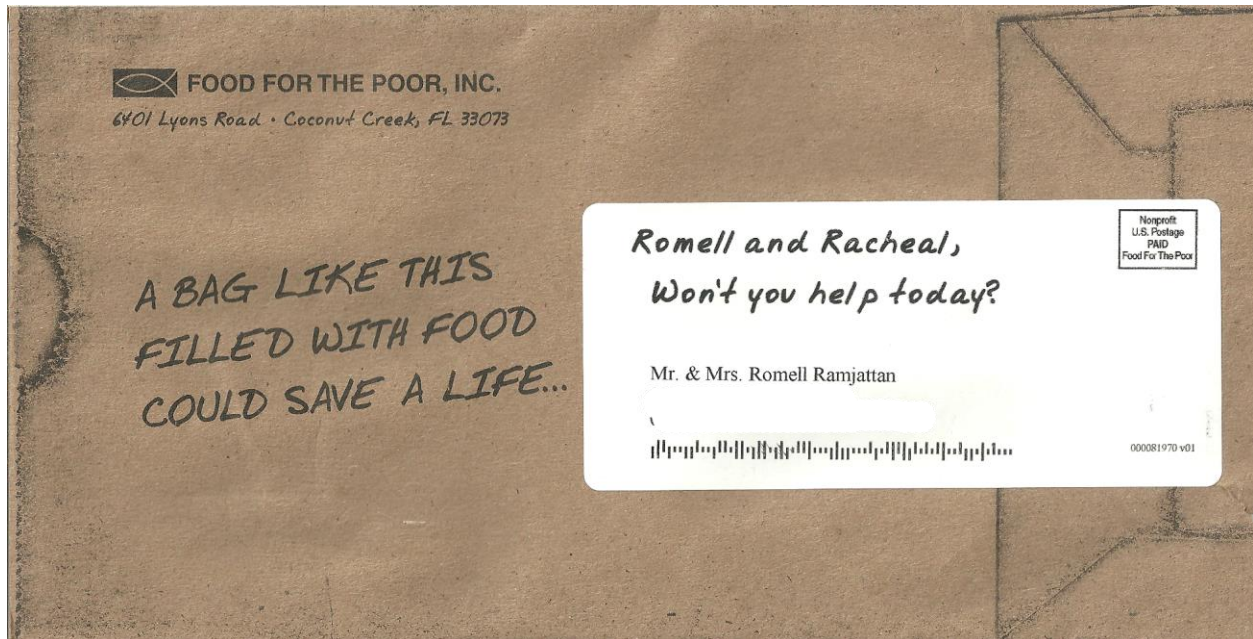

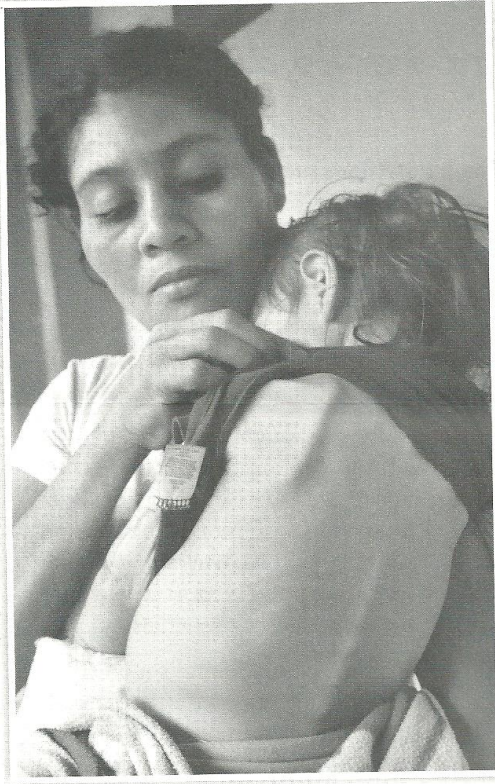

Ena held Meilin close to her and stroked her thinning strands of hair. "I brought her here because I wanted her to live; I never wanted her to die..." Ena said.

Ena draws strength from her faith, asking God to heal Meilin. At night, Meilin falls asleep to the soothing sound of her mother singing hymns to her and praying over her. "I ask Him [God] to help my daughter," she said. "I just know that He is listening."

Meilin's parents love her, but they are too poor to meet her needs. Meilin, who is approaching her second birthday, weighs just 16.8 pounds. "I feel sorry to see her like that. What am I going to do? I can't do anything," Ena said.

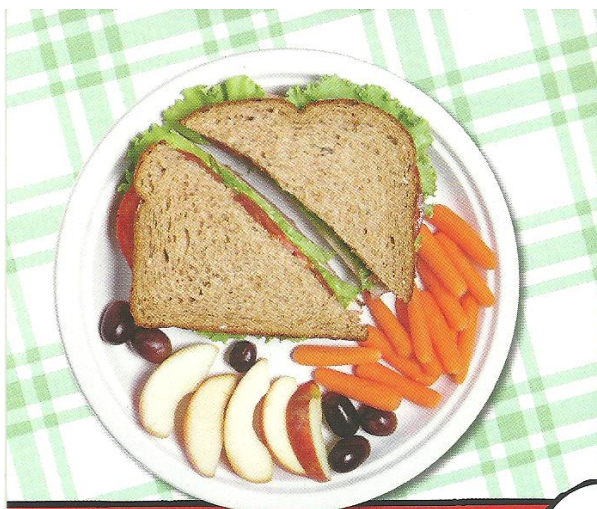

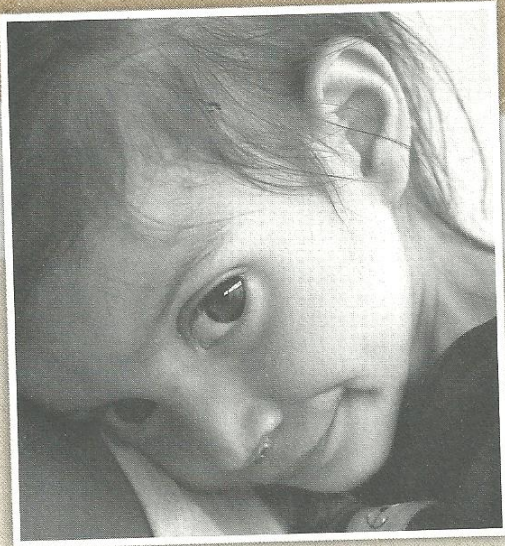

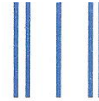
